AN ORDINANCE APPOINTING A CITY CLERK/CITY ADMINISTRATOR AND APPROVING AN EMPLOYMENT AGREEMENT

WHEREAS, the Board of Aldermen of the City of Sunset Hills has conducted an exhaustive nationwide search to identify eligible, qualified candidates for the position of City Clerk/City Administrator; and

WHEREAS, the Board of Aldermen deems it to be in the best interest of the residents of the City of Sunset Hills to hire a City Clerk/City Administrator and offer an Employment Agreement that sets forth the conditions of employment of Eric M. Sterman as City Clerk/City Administrator of the City of Sunset Hills.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF SUNSET HILLS, ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

Section 1. The Employment Agreement attached hereto as Exhibit 1 is approved and the Mayor is authorized to sign the same on behalf of the City of Sunset Hills.

Section 2. The new City Clerk/City Administrator shall have the duties, responsibilities and authority as are prescribed in the Code of Ordinances of the City of Sunset Hills, Missouri.

Section 3. All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict repealed.

Section 4. This ordinance shall take effect and be in full force from and after its passage and approval.
